Fees and Costs**

1173.01 SCHEDULE OF FEES AND COSTS.

The City of Harrison hereby establishes the following schedule of fees and costs for zoning certificates, permits, appeals, reviews, and other matters pertaining to this Ordinance.

- A. Payment of Fees and Costs.
The established fees and costs shall accompany each application for a zoning certificate, permit, appeal, review, and other matters pertaining to this Ordinance.
- B. Additional Fees and Costs.
In the event the fees and costs established herein for a particular certificate, application, permit, appeal, review or any other matter pertaining to this Ordinance is insufficient to pay all costs incurred by the City, the additional fees and costs shall be chargeable to the applicant and payable on demand.
- C. Fees and Costs not Returnable.
Fees and costs required in any of these regulations or in any parts of this Ordinance shall not be returnable for any cause, regardless of the outcome or decision on any application.
- D. Deposit of Fees and Costs.
All fees and costs shall be deposited with the Director of Finance and credited to the General Revenue Fund of the City of Harrison.
- E. Fees Exempted.
The City of Harrison and/or Harrison Township Trustees shall be exempt from payment of any and all fees established by this Ordinance.
- F. Adjustment of Fees and Costs.
From time to time, and as deemed necessary by Council, this fee and cost schedule shall be adjusted by Council and by Ordinance. The most recent schedule shall be posted for public inspection in the office of the Director of Zoning.
- G. Violation.
Any project started without an approved zoning certificate shall be charged double fee.

1173.02 FEE SCHEDULE FOR ZONING CERTIFICATES.

- A. Residential Buildings.
 - (1) Single family dwelling \$ 40.00
 - (2) Two family dwelling, including a duplex 40.00 per unit
 - (3) Multiple family dwelling or Condominium Dwelling for the first two (2) units plus \$20.00 for each unit in excess of two (2), with a maximum fee of \$250.00
 - (4) Hotel or Motel for the first two (2) units plus \$25.00 each unit in excess of two (2), with a maximum fee of \$350.00.
 - (5) Addition 20.00
 - (6) Structural alteration 20.00
- B. Nonresidential Buildings.
Any building or addition thereto up to and including:
 - (1) 5,000 sq. ft. \$ 100.00
 - (2) 5,001 to 10,000 sq. ft. 150.00

- (3) 10,001 to 15,000 sq. ft. 200.00
- (4) 15,001 to 20,000 sq. ft. 250.00
- (5) 20,001 sq. ft. or more 275.00

C. Calculation of Square Feet.

- (1) The square feet of each floor of a proposed nonresidential building shall be used to calculate the total square feet for Zoning Certificate fee.
- (2) The square feet of a proposed addition to an existing nonresidential building shall be used for Zoning Certificate fee.

D. Alteration.

Structural alteration \$ 30.00

E. Other Zoning Certificate Fees.

- (1) Land use, not involving any building or structure \$ 25.00
- (2) Change in use of building or land \$ 25.00
- (3) Change of occupancy \$ 25.00
- (4) Fuel oil storage tanks, waste oil storage and gasoline storage tanks (new installation or replacement above or below ground)
 - A. First tank \$100.00
 - B. Each additional tank \$ 50.00
- (5) Signs.
 - A. Permanent \$35.00
 - B. Temporary \$20.00
 - C. Sign change \$20.00

For a Nonresidential Use or Building with a maximum of \$80.00 for two (2) or more on the same application. \$40.00

- C. The fee for an Accessory Use, Building or Structure not established by this Ordinance shall be the same as the fee comparable to an established Accessory Use, Building or Structure.

 - C. Outdoor residential lighting along drives, walks, or patios.
